This plan is reviewed and updated annually to ensure that contingency planning at The Bridge Easton School is managed in accordance with current requirements and regulations.



# Purpose of the plan

This plan examines potential risks and issues that could cause disruption to the examination/assessment process.

By outlining actions/procedures to be invoked in case of disruption it is intended to mitigate the impact these disruptions have on processes at The Bridge Easton School.

Alongside internal processes, this plan is informed by the Ofqual Exam system contingency plan: England, Wales and Northern Ireland which provides guidance in the publication, 'What schools and colleges and other centres should do if exams or other assessments are seriously disrupted', the JCQ Joint Contingency Plan for the Examination System in England, Wales and Northern Ireland and the JCQ document Preparing for disruption to examinations (Effective from 1 September 2024).

This plan details how The Bridge Easton School complies with the JCQ's **General Regulations for Approved Centres** (5.3 Centre management) by having in place for inspection that must be reviewed and updated annually, a written contingency plan which covers all aspects of examination/assessment administration and delivery.

**Contingency arrangements** 

The centre **must** have an up to date written contingency plan.

The contingency plan **must** cover all aspects of examination/assessment administration and delivery. Senior leaders **must** have robust contingency arrangements in place that will minimise the risk to examination/assessment administration and delivery and any adverse impact on candidates.

The plan must cover the following scenarios:

- The Head of Centre, relevant senior leader(s) with oversight of examination and assessment administration, SENDCo (or equivalent role), Examinations Officer or any other key staff essential to the examination process being absent at a critical stage of the examination cycle
- The potential impact of other events such as flooding which could lead to all or parts of the centre becoming unavailable
- · Potential issues with the centre's IT systems

As part of the contingency plan the centre **must** identify an alternative site if examinations cannot be conducted at the registered address. Larger centres may require more than one potential alternative site or different sites for different Year Groups.

The centre **must** have at least one senior member of staff (senior designated contact) who is available to manage emergency requests from awarding bodies that are results related during the summer holidays. However, a number of contacts can be provided to reduce the risk of this falling on one individual throughout the summer holidays.

The centre **must** ensure that candidates' work is backed-up and should consider the contingency of candidates' work being backed-up on two separate devices, including one off-site back-up. Appropriate security arrangements must be implemented which protect candidates' work in the event of IT system corruption and cyber-attacks (GR 3.17-19).

Operating across more than one centre

We do not operate across more than one centre.



# National Centre Number Register and other information requirements

The Head of Centre will ensure that the centre responds to the National Centre Number Register annual update by the end of October every year which includes providing senior designated contact details (this might include a personal mobile number and/or email address). These must be the contact details of someone who can be reached in an emergency if the centre is closed over the summer and who can mobilise resources to respond to the issue (GR 5.3).

Head of Centre absence at a critical stage of the exam cycle

The Assistant Headteacher of Centre will assume responsibility for oversight of the Exams Season if the Head of Centre is absent.

#### Possible causes of disruption to the exam process

1. Exams officer extended absence at a critical stage of the exam cycle

#### Criteria for implementation of the plan

Key tasks required in the management and administration of the exam cycle not undertaken including:

#### **Planning**

- Annual data collection exercise not undertaken to collate information on qualifications and awarding body specifications being delivered
- Annual exams plan not produced identifying essential key tasks, key dates and deadlines
- Sufficient invigilators not recruited

#### **Entries**

- Awarding bodies not being informed of early/estimated entries which prompts release of early information required by teaching staff
- Candidates not being entered with awarding bodies for external exams/assessment
- Awarding body entry deadlines missed or late or other penalty fees being incurred

# Pre-exams

- Invigilators not trained or updated on changes to instructions for conducting exams
- Exam timetabling, rooming allocation and invigilation schedules not prepared
- Candidates not briefed on exam timetables and awarding body information for candidates
- Confidential exam/assessment materials and candidates' work not stored under required secure conditions
- Internal assessment marks and samples of candidates' work not submitted to awarding bodies/external moderators

#### Exam time

- Exams/assessments not taken under the conditions prescribed by awarding bodies
- Required reports/requests not submitted to awarding bodies during exam/assessment periods, for example very late arrival, suspected malpractice, special consideration
- Candidates' scripts not dispatched as required for marking to awarding bodies

The centre will:

The Headteacher or Assistant Headteacher to take over responsibilities and SLT to nominate additional administration support as needed in line with JCQ guidelines (see Centre Structure chart for roles and responsibilities).

# 2. SENCo (or equivalent role) extended absence at a critical stage of the exam cycle

#### Criteria for implementation of the plan

Key tasks required in the management and administration of the access arrangements process within the exam cycle not undertaken including:

#### **Planning**

- Candidates not tested/assessed to identify potential access arrangement requirements
- Centre fails to recognise its duties towards disabled candidates as defined under the terms of the Equality Act 2010
- Evidence of need and evidence to support normal way of working not collated

#### Pre-exams

- Approval for access arrangements not applied for to the awarding body
- Centre-delegated arrangements not put in place
- Modified paper requirements not identified in a timely manner to enable ordering to meet external deadline
- Staff (facilitators) providing support to access arrangement candidates not allocated and trained

#### Exam time

Access arrangement candidate support not arranged for exam rooms

Other criteria: No criteria identified.

Centre actions to mitigate the impact of the disruption listed above - the centre will:

1. SLT to nominate a deputy to cover the role with the assistance of the Exams Officer

# 3. Teaching staff extended absence at a critical stage of the exam cycle

#### Criteria for implementation of the plan

Key tasks not undertaken including:

 Early/estimated entry information not provided to the exams officer on time; resulting in pre-release information not being received



- Final entry information not provided to the Exams Officer on time; resulting in candidates not being entered for exams/assessments or being entered late/late or other penalty fees being charged by awarding bodies
- Non-examination assessment tasks (including controlled assessment and coursework) not set/issued/taken by candidates as scheduled
- Candidates not being informed of centre assessed marks before marks are submitted to the awarding body and therefore not being able to consider appealing internal assessment decisions and requesting a review of the centre's marking
- Internal assessment marks and candidates' work not provided to meet awarding body submission deadlines

Other centre actions: No other actions identified.

Centre actions to mitigate the impact of the disruption listed above – the centre will:

• SLT of the centre will nominate subject leaders to cover the role/tasks

# 4. Invigilators - lack of appropriately trained invigilators or invigilator absence

#### Criteria for implementation of the plan

- Failure to recruit and train sufficient invigilators to conduct exams
- Invigilator shortage on peak exam days
- Invigilator absence on the day of an exam

Other centre actions: No other actions identified.

Centre actions to mitigate the impact of the disruption listed above - the centre will:

- Internal invigilators, Administration Team and Family Support Officers to be utilised as the team of trained staff, due to students needing familiar adults to signal safety, linked to SEMH and other needs outlined in EHCPS
- All Secondary staff will train as invigilators to ensure there are sufficient known staff to mitigate risk

# 5. Exam rooms - lack of appropriate rooms or main venue(s) unavailable at short notice

#### Criteria for implementation of the plan

- Exams Officer unable to identify sufficient/appropriate rooms during exams timetable planning
- Insufficient rooms available on peak exam days
- Main exam venues unavailable due to an unexpected incident at exam time
- SLT/Exams Officer to source alternative venues or KS3 areas of the school in line with JCQ regulations.

Centre actions to mitigate the impact of the disruption listed above - the centre will:

where the main exam venue(s) are unavailable due to an unexpected incident at exam time, where
possible, make use of other available rooms within the centre, prioritising candidates whose
progression will be severely delayed if they do not take their exam or timetabled assessment when
planned



- identify whether the exam or timetabled assessment can be sat at an alternative venue, in agreement with the relevant awarding body
- where the main exam venue(s) are unavailable due to an unexpected incident at exam time, where
  possible, move to alternative venue, prioritising candidates whose progression will be severely
  delayed if they do not take their exam or timetabled assessment when planned

Alternative site(s) details: To be confirmed.

- communicate with candidates (and where appropriate, parents/carers) any changes to the exam or assessment timetable or to the venue
- Communication details: Via phone, email and BOOP.
- ensure the secure transportation of question papers or assessment materials to the alternative venue
- after the exam, consider whether any candidate's ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration

Other centre actions: No other actions identified.

#### 6. Cyber-attack

#### Criteria for implementation of the plan

• Where a cyber-attack may compromise any aspect of delivery

Other centre actions: No other actions identified.

Centre actions to mitigate the impact of the disruption listed above - the centre will:

- Exams Officer and IT Manager to communicate with awarding bodies/MIS provider at the outset to resolve the issue
- Exams Officer to use awarding body secure areas and other internal systems if required

# 7. Failure of IT systems

#### Criteria for implementation of the plan

- IT system corruption affecting candidates' work
- MIS/IT system failure at final entry deadline
- MIS/IT system failure during exams preparation
- MIS/IT system failure at results release time

Other centre actions: No other actions identified.

Centre actions to mitigate the impact of the disruption listed above – the centre will:

- Exams Officer and IT Manager to communicate with awarding bodies/MIS provider at the outset to resolve the issue
- Exams Officer to use awarding body secure areas and other internal systems if required



# 8. Emergency evacuation of the exam room (or centre lockdown)

#### Criteria for implementation of the plan

 Whole centre evacuation (or lockdown) during exam time due to serious incident resulting in exam candidates being unable to start, proceed with or complete their exams

#### Other criteria:

- Exams Officer will contact the relevant awarding organisation and follow its instructions
- Exams Officer will take advice, or follow instructions, from relevant local or national agencies in deciding whether the school or college is able to open
- Head of Centre/Exams Officer to identify whether the exam can be sat at an alternative venue, in agreement with the relevant awarding organisation
- Where accommodation is limited, prioritise students whose progression will be severely delayed if they do not take their exams when planned
- Communicate with parents, carers and students regarding any changes to the exam timetable
- Advise students, where appropriate, to sit exams in the next available series

Centre actions to mitigate the impact of the disruption listed above - the centre will:

- Refer to and invoke its (exams) emergency evacuation policy/procedure in line with JCQ's 'Centre emergency evacuation procedure' (or its (exams) lockdown policy)
- Contact the relevant awarding body as soon as possible and follow its instructions
- Where accommodation is limited, prioritise candidates whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned
- after the exam, consider whether any candidate's ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration

Other centre actions: No other actions identified.

# 9. Disruption of teaching time in the weeks before an exam - centre closed for an extended period

# Criteria for implementation of the plan

 Centre closed or candidates are unable to attend for an extended period during normal teaching or study supported time, interrupting the provision of normal teaching and learning

## Other criteria:

- SLT to source alternative venue and methods of learning for an appropriate course of action
- Centre to communicate with parents/carer and students about the disruption for teaching & learning
- School website and BOOP to be used for updates along with extra administration support for calls to parents/carers and take the necessary action to prepare students as usual for examinations
- Exams Officer to advise if exams can be sat in a different series
- Exams Officer to apply for special consideration as appropriate

Centre actions to mitigate the impact of the disruption listed above - The centre will:

• recognise it remains the responsibility of the centre to prepare students, as usual, for examinations



- facilitate alternative methods of learning
- communicate with candidates (and where appropriate, parents/carers) information relating to alternative methods of learning
- **Communication** details: Via website, phone calls, emails and BOOP.
- Take advice offered by the awarding body regarding alternative arrangements for conducting examinations that may be available
- Take advice offered by the awarding body on the options for candidates who have not been able to take scheduled examinations
- Advise candidates, where appropriate, of the opportunities to take their exam or assessment at a later date

Other centre actions: No other actions identified.

# 10. Candidates may not be able to take examinations - centre remains open

# Criteria for implementation of the plan

• Candidates may not be able to attend the examination centre to take examinations as normal because of a crisis

#### Other criteria:

- Exams Officer to liaise with candidate and see if exam can be sat at an alternative venue in agreement with the awarding body and in line with JCQ guidance
- Exams Officer to apply for special consideration as appropriate

Centre actions to mitigate the impact of the disruption listed above - the centre will:

- focus on options that enable candidates to take their examinations (referencing the JCQ document Preparing for disruption to examinations)
- take advice offered by the awarding body on the options for candidates who have not been able to take scheduled examinations
- discuss alternative arrangements with the awarding body if a candidate misses an exam or loses their assessment due to an emergency, or other event, outside of the candidate's control
- identify whether the exam or timetabled assessment can be sat at an alternative venue, in agreement
  with the relevant awarding body, ensuring the secure transportation of questions papers or
  assessment materials to the alternative venue
- communicate with candidates (and where appropriate, parents/carers) any changes to the exam or assessment timetable or to the venue

Communication details: Via the website, emails, telephone calls and BOOP.

 consider whether any candidates' ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration

Other centre actions: No other actions identified.



# 11. Centre may not be able to open as normal during the examination period

(Including in the event of the centre being unavailable for examinations owing to an unforeseen emergency)

#### Criteria for implementation of the plan

Centre may not be able to open as normal for scheduled examinations

#### Other criteria:

- SLT to try to keep centre open for examinations only if possible
- SLT to find an alternative venue in agreement with the relevant awarding bodies/JCQ
- Centres may offer candidates the opportunity to sit exams in the next available series
- Exams Officer to apply for special considerations as appropriate

Centre actions to mitigate the impact of the disruption listed above - The centre will:

- focus on enabling candidates to take their examinations
- take advice, or follow instructions, from relevant local or national agencies in deciding whether the centre is able to open
- contact the relevant awarding body as soon as possible and follow its instructions. This could include
  implementing alternative arrangements for the conducting of examinations and notifying the JCQ
  Centre Inspection Service of an alternative site arrangement by submitting the JCQ Alternative Site
  form online, using the Centre Admin Portal
- contact the relevant awarding body as soon as possible and follow its instructions
- discuss alternative arrangements with the awarding body if the exam or assessment cannot take place
- follow guidance provided by the awarding body on the conduct of examinations in such circumstances
- where accommodation is limited, prioritise candidates whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned
- communicate with candidates (and where appropriate, parents/carers) any changes to the exam or assessment timetable or to the venue
- Alternative site(s) details: to be confirmed.
- Communication details: Via email, website, phone call and BOOP.
- Consider whether any candidates' ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration

Other centre actions: No other actions identified.

# 12. Disruption in the distribution of examination papers

#### Criteria for implementation of the plan

• Disruption to the distribution of examination papers to the centre in advance of examinations

# Other criteria:

- Exams Officer to contact awarding body to organise alternative delivery of exam papers
- Exams Officer to access papers from exam board secure area & store securely
- 3. Inform SLT as additional courier deliveries likely to the centre



Exams Officer to check papers are on site 24hrs preceding the exam

Centre actions to mitigate the impact of the disruption listed above- the centre will:

- 4. Liaise with awarding bodies regarding the provision of electronic access to examination papers via a secure external network and will ensure when copies are received/made these are stored under secure conditions
- Follow guidance provided by the awarding body on the conduct of examinations in such circumstances
- Understand that as a last resort, and in close collaboration with centres and regulators, awarding
  organisations will consider scheduling of the examination on an alternative date
- 5. Communicate with candidates (and where appropriate, parents/carers) any changes to the exam or assessment timetable or to the venue

Other centre actions: No other actions identified.

# 13. Delay in collection arrangements for completed examination scripts

#### Criteria for implementation of the plan

Delay in normal collection arrangements for completed examination scripts/assessment evidence

#### Other criteria:

- Exams Officer to contact the awarding body and normal collection agency (Parcelforce)
- Exams Officer to keep scripts securely stored until awarding bodies re-arrange collection

Centre actions to mitigate the impact of the disruption listed above - the centre will:

- Where examinations are part of the national 'yellow label' service or where awarding organisations
  arrange collections, seek advice from the relevant awarding organisations and do not make your own
  arrangements for transportation unless told to do so by the awarding organisation
- For any examinations where the centre makes its own arrangements for transportation, investigate
  alternative dispatch options that comply with the requirements detailed in the JCQ document
  instructions for conducting examinations
- Ensure the secure storage of completed examination scripts until as close to the collection time as possible

Other centre actions: No other actions identified.

# 14. Assessment evidence is not available to be marked

# Criteria for implementation of the plan

- Large scale damage to or destruction of completed examination scripts/assessment evidence before it can be marked
- Completed examination scripts/assessment evidence does not reach awarding organisations

# Other criteria:

- Exams Officer to contact awarding bodies for advice
- SLT to contact students as appropriate



- Awarding body may generate candidate marks for affected assessments based on other appropriate evidence in consultation with the regulators, this will be confirmed
- Exams Officer to apply for special consideration as appropriate

Centre actions to mitigate the impact of the disruption listed above - the centre will:

- Liaise with the awarding body to determine if candidate marks for affected assessments may be able
  to be generated based on other appropriate evidence of candidate achievement as defined by the
  awarding body
- Where marks cannot be generated by awarding body, inform candidates they may need to retake the
  affected assessment in a subsequent assessment series

Other centre actions: No other actions identified.

# 15. Centre unable to distribute results as normal (including in the event of the centre being unavailable on results day owing to an unforeseen emergency) or facilitate post-results services

#### Criteria for implementation of the plan

 Centre is unable to access or manage the distribution of results to candidates, or to facilitate postresults services

#### Other criteria:

- Exams Office to contact awarding bodies for advice for alternative options
- Centre to arrange to access its results at an alternative site
- Centre to make arrangements to access the post results service from an alternative site
- Centre to share facilities with other centres if possible
- Centre to communicate any changes with parents/carer and students as appropriate

Centre actions to mitigate the impact of the disruption listed above - the centre will:

- Make arrangements to access its results at an alternative venue/share facilities with another centre if this is possible, in agreement with the relevant awarding body
- Make arrangements to coordinate access to post-results services from an alternative venue
- Alternative site(s) details: to be confirmed.
- Make arrangements to make post-results requests at an alternative location
- Contact the relevant awarding body if electronic post-results requests are not possible
- Inform candidates of any alternative arrangements in place for the distribution of results and the facilitation of post-results services
- Communication details: Via email and phone call.

Other centre actions: No other actions identified.

# 16. Any other cause of disruption to the exam process

"This document was updated in October 2023 to include Ofqual's final decisions on long-term resilience arrangements, and the Department for Education (DfE)'s guidance for education settings with confirmed reinforced autoclaved aerated concrete (RAAC).

In addition to this guidance, you will need to be aware of your specific responsibilities for local and national school preparations and contingencies. You should also follow advice from relevant public health bodies.

## **Contingency planning**

Awarding organisations are required to establish, maintain and comply with an up-to-date detailed written contingency plan, to mitigate any incident they have identified may occur. This includes having communication plans for external parties (<u>Ofqual General Condition of Recognition A6</u>). Schools and colleges should also be prepared for possible disruption to exams and assessments and make sure staff are aware of these plans.

#### Disruption to assessments or exams

In the absence of any instruction from the relevant awarding organisation, you should make sure that any exam or timetabled assessment takes place if it is possible to hold it. This may mean relocating to alternative premises. You should discuss alternative arrangements with your awarding organisation if:

- The exam or assessment cannot take place
- A student misses an exam or loses their assessment due to an emergency, or other event, outside of the student's control

You may also wish to see the <u>JCQ's notice to centres on exam contingency plans</u> and <u>JCQ's notice on preparing for disruption to examinations</u> in England, Wales and Northern Ireland for qualifications within its scope.

#### Steps you should take

# **Exam planning**

Review your contingency plans well in advance of each exam or assessment series. Consider how, if the contingency plan is invoked, you will comply with the awarding organisation's requirements.



Schools, colleges and other exam centres must speak to the relevant awarding organisations as soon as possible if they are expecting any disruption that might affect the sitting of exams and assessments.

#### In the event of disruption

- Contact the relevant awarding organisation and follow its instructions
- Take advice, or follow instructions, from relevant local or national agencies in deciding whether your centre is able to open
- Identify whether the exam or timetabled assessment can be sat at an alternative venue, in agreement
  with the relevant awarding organisation, ensuring the secure transportation of questions papers or
  assessment materials to the alternative venue
- Where accommodation is limited, prioritise students whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned
- In the event of an evacuation during an examination please refer to JCQ's Centre emergency evacuation procedure
- Communicate with students, parents and carers any changes to the exam or assessment timetable or to the venue
- Communicate with any external assessors, invigilators or relevant third parties regarding any changes to the exam or assessment timetable

#### After the exam

- Consider whether any students' ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply to the relevant awarding organisation for special consideration
- Advise students, where appropriate, of the opportunities to take their exam or assessment at a later date
- Ensure that scripts are stored under secure conditions
- Return scripts to awarding organisations in line with their instructions. Never make alternative arrangements for the transportation of completed exam scripts, unless told to do so by the awarding organisation

#### Steps the awarding organisation should take

# **Exam planning**

- Establish and maintain, and at all times comply with, an up-to-date, written contingency plan
- Ensure that the arrangements in place with centres and other third parties enable them to deliver and award qualifications in accordance with their conditions of recognition

# In the event of disruption

- Take all reasonable steps to mitigate any adverse effect, in relation to their qualifications, arising from any disruption
- Provide effective guidance to any of their centres delivering qualifications
- Ensure that where an assessment must be completed under specified conditions, students are able to complete the assessment under those conditions (other than where any reasonable adjustments or special considerations require alternative conditions)
- Promptly notify the relevant regulators about any event which could have an adverse effect on students, standards or public confidence



• Coordinate its communications with the relevant regulators where the disruption has an impact on multiple centres or a wide range of learners

#### After the exam

Consider any requests for special consideration for affected students; for example, those who may have lost their internally assessed work or whose performance in assessments or exams could have been affected by the disruption.

If any students miss an exam or are disadvantaged by the disruption or if some of the students have been adversely affected by the disruption, you should ask the awarding organisation about applying for special consideration.

Decisions about special consideration, when it is or is not appropriate, is for each awarding organisation to make. Their decisions might be different for different qualifications and for different subjects, depending on their specific policies.

See also JCQ's guidance on special consideration

#### Wider communications

The regulators, Ofqual in England, <u>Qualifications Wales</u> in Wales and <u>CCEA Regulation</u> in Northern Ireland, will share timely and accurate information, as required, with awarding organisations, government departments and other stakeholders.

The <u>DfE in England</u>, the <u>DfE in Northern Ireland</u>, and the <u>Welsh Government</u> will inform the relevant government ministers as soon as it becomes apparent that there will be significant local or national disruption, and ensure that they are kept updated until the matter is resolved.

Awarding organisations will alert the <u>Universities and Colleges Admissions Service (UCAS)</u> and the <u>Central Applications Office (CAO)</u> about any impact of the disruption on their deadlines and liaise regarding student progression to further and higher education.

Awarding organisations will alert relevant professional bodies or employer groups if the impact of disruption particularly affects them.

Widespread national disruption to the taking of examinations or assessments

As education is devolved, in the event of any widespread sustained national disruption to examinations or assessments, national government departments will communicate with regulators, awarding organisations and centres prior to a public announcement. Regulators will provide advice to government departments on implications for examinations and assessments, including exam timetables.

In September 2023, Ofqual and the DfE published joint consultation decisions on long-term resilience arrangements. As in 2023, Ofqual has provided guidance on collecting evidence of student performance to ensure resilience in the gualifications system for students entering GCSEs, AS and A levels, the Advanced Extension Award and Project qualifications. For VTQs and other qualifications used alongside or instead of GCSEs, AS and A levels, awarding organisations will provide guidance where needed and will contact schools and colleges with more information.

In December 2022, Qualifications Wales published <u>guidance for contingency assessment arrangements</u> for GCSEs, AS and A levels and Skills Challenge Certificates in the event that a national decision is made to cancel exams. This guidance is still relevant for the current academic year.

The DfE has updated its guidance on <u>handling strike action in schools</u> in England in light of the industrial action in 2023. The guidance recommends schools should prioritise the running of examinations and assessments on any strike days, and should review their contingency plans to make this happen. Schools, colleges and other exam centres must speak to the relevant awarding organisations if they are expecting any disruption that might affect the sitting of exams and assessments.

The DfE has also issued guidance for education settings with confirmed reinforced autoclaved aerated concrete (RAAC) in their buildings. It includes the need for contingencies for possible disruption to examinations and links to the existing emergency planning guidance.

JCQ guidance taken directly from <u>Instructions for conducting examinations 2024-2025</u> section 15:

#### **Contingency planning**

"15.1 The qualification regulators, awarding bodies and government departments responsible for education have prepared and agreed information for schools and colleges in the event of examinations being seriously disrupted. This jointly agreed information will ensure consistency of response in the event of major disruption to the examinations system affecting significant numbers of candidates.

- 15.2 In addition, awarding bodies have their own well-established contingency plans in place to respond to disruptions. It is important that exams officers who are facing disruption liaise directly with the relevant awarding body/bodies.
- 15.3 All centres must have a written examination contingency plan which covers all aspects of examination administration. This will allow members of the senior leadership team to act immediately in the event of an emergency or where the head of centre, examinations officer or SENCo is absent at a critical stage of the examination cycle. The examination contingency plan should reinforce procedures in the event of the centre being unavailable for examinations owing to an unforeseen emergency.

All relevant centre staff must be familiar with the examination contingency plan. Consideration should be given as to how these arrangements will be communicated to candidates, parents and staff should disruption to examinations occur.

- 15.4 In the event that the head of centre decides the centre cannot be opened for scheduled examinations, the centre's contingency plan must be invoked, utilising the centre's alternative site(s) and the relevant awarding bodies must be informed as soon as possible. Awarding bodies will be able to offer advice regarding the alternative arrangements for conducting examinations that may be available and the options for candidates who have not been able to take scheduled examinations.
- 15.5 The awarding bodies will designate 'contingency sessions' for examinations, summer 2025. This is consistent with the qualification regulators' document Exam system contingency plan: England, Wales and Northern Ireland www.gov.uk/government/publications/exam-system-contingency-plan-england-wales-and-northern-ireland



- 15.6 The designation of 'contingency sessions' within the common examination timetable is in the event of national or significant local disruption to examinations. It is part of the awarding bodies' standard contingency planning for examinations.
- 15.7 In the event that there is national disruption to a day of examinations in summer 2025, the awarding bodies will liaise with the qualification regulators and government departments to agree the most appropriate option for managing the impact. As a last resort the affected examinations will be rescheduled. Although every effort would be taken to keep the impact to a minimum, it is possible that there could be more than one timetable date affected following the disruption, up to and including the last contingency day. Centres will be alerted if it was agreed to reschedule the examinations and the affected candidates will be expected to make themselves available in such circumstances. The decision regarding the re-scheduling of examinations will always rest with the awarding body. The centre must conduct the examination on the scheduled date unless instructed to do otherwise by the awarding body.
- 15.8 Where candidates choose not to be available for the rescheduled examination(s) for reasons other than those traditionally covered by special consideration, they will not be eligible for enhanced grading arrangements. Centres must therefore ensure candidates and parents are aware of the contingency arrangements so that they may take them into account when making their plans for the summer. However, the awarding bodies will not insist upon candidates being available throughout the entire timetable period as a matter of course."
